

SUGGESTED PASTOR'S, LECTOR'S, or PROLIFE COORDINATOR'S ANNOUNCEMENT

Abortion is the most pressing moral issue of our time, and today, the most extreme federal legislation ever proposed concerning abortion, is pending in the US Congress.

Abortion is NOT a legitimate health care item, because there is nothing healthy about killing babies, hurting women, and leaving women to live a life of regret. Abortion should not even be part of the discussion in the proposed health care legislation.

But, unfortunately, in the proposed health care legislation, abortion funding and coverage are firmly in place. If passed by congress, and signed into law by President Obama, this proposed legislation would be the worst setback for the proLife cause in the history of our nation... far worse than Roe v. Wade itself.

However, we are still a nation with a government "of the people" and if we stand up, and make our voices heard, we will win this battle!

So much is at stake this year, and now, the annual nationwide ProLife Signature Ad Petition is the MOST effective and important petition in the country. Here is why:

1. We use your name, and all signers' names, repeatedly in the legislative process; several times, not just once like most other petitions. The lawmakers easily forget the one-time petitions, but we do not let them forget ours.
2. We target the right people; using your signature to persuade the undecided Senators and Representatives who are about to make a procedural vote, or a final vote, that matters to you.
3. We time our correspondence to reach the lawmaker's desk at the most influential time - usually prior to him or her announcing a decision. Timing is everything in the legislative process, and no other petition in the country has a history of, or capability of, better timing than we do! *(Note that in addition, we sometimes will use your signature as a persuasive tool, with those lawmakers who have already announced a position, in the hope of changing his or her mind, or in keeping them from doing so.)*
4. Since many lawmakers themselves sign our Annual Signature-Ad Petition, we have a solid reputation of using only verifiable, valid signatures.

5. The 2007 ProLife Signature-Ad Petition is the ONLY CITIZEN'S PETITION in the history of the United States, to ever be officially accepted by the US Supreme Court. (For details see: <http://www.kcfl.net/kcfl/doc/newsr/more%20important%20than%20voting-stacy.pdf>) If a health care plan makes it through congress, a Supreme Court challenge is a distinct possibility. If that happens, we will submit the 2010 Petition to the US Supreme Court in the same way we did the 2007 Petition. This alone is an enormous reason to have your name included on the 2010 ProLife Signature-Ad Petition. How else are you going to petition the Supreme Court? *(You cannot call or write to your Supreme Court Justice in the same way that you call or write to your congressional representatives!)*

6. Finally, this Petition, as published on the KCFL Website is also a great campaign tool. Anyone can look up - and isolate - signers from their particular state or city, in order to find people who are likely to help in a particular campaign

For these reasons, we urge you to make your opinion known, by signing the 2010 ProLife Petition today!
