

These SEVEN most recent CONFIRMED SAVES show how important it is to be on-site daily!



Monday, October 10, 2005:

CONFIRMED SAVE: Sedg Co. tag; a red-haired lady, early 20's, came in at about 12:45 pm, but stopped at the gate and accepted a re-direct to Choices Medical Clinic from KCFL volunteer Terry. She was here with a boyfriend and her Dad ...all three went into Choices and saw the sonogram. She talked to Terry on the way out of Choices, and they are keeping the baby, (*it is a boy*). They were told previously that the baby was deformed and that is why they were going to Tiller's. However the sonogram at Choices showed no abnormalities whatsoever. Terry tried to get the name of the doctor who referred her to Tiller, but she did not want to say, for fear of getting her doctor in trouble. ###

Wednesday, October 12, 2005:



CONFIRMED SAVE - El Dorado, Butler Co. tag. Mother-37 and her Daughter- about 20, with an infant baby, stopped at the gate to talk with KCFL volunteer Donna. Donna assumed that it was the 20-year-old who was here for an abortion, but it was the Mother (Grandmother) who was planning on having an abortion due to her advanced age. She accepted printed material from Donna and went over to Choices, after picking up an info-pack from Tiller's. When they came out of Choices, they stopped and talked to KCFL volunteer Jennifer, who had replaced Donna on-site. Choices had assured her that at age 37 she was not too old to have a baby. She, (the Grandmother) told Jennifer that she was not having the abortion. ###

Tuesday, October 18, 2005: TURN-AROUND from last week, upgraded to CONFIRMED SAVE today. At about 1:45 pm, a Caucasian



lady, with KS tags, (county unknown) stopped to talk with KCFL volunteer Donna on her way out of Tiller's. She is the mother of a younger lady who was counted as a Turn-around on Thursday last week. She spoke openly to Donna about their change of heart and their decision to keep the baby. Her reason for coming in to Tiller's today was to pick up a check for the refundable portion of what they had paid Tiller in advance. ###

Friday, October 21, 2005: CONFIRMED

SAVE - A Choices Medical Clinic worker told Donna that a client who came in yesterday was dissuaded from turning in to Tiller's parking lot by the ProLife volunteers who were standing at the gate. Instead, she decided to come in to Choices Medical Clinic upon seeing the sign for the offer of \$100 for coming to Choices first. After seeing the sonogram, she decided to keep her baby. The volunteers at the gate Thursday were totally unaware that by their mere presence that they had saved a life yesterday, thinking that the client may have been a scheduled appointment at Choices. (*The presence of prayerful ProLife volunteers at the gate routinely turns away would-be abortion clients. In most cases, these do not appear on anyone's list for statistical counts. This case is exceptional, only in that we inadvertently heard about it.*) ###



Wednesday, November 2, 2005: CONFIRMED

SAVE - (Therese Dippolito and Monica Maus)

At about 4 pm, a couple inbound to



Tiller's, stopped at the gate to talk to Therese and Monica. The lady was crying. Therese did not have printed material on her, so in haste, she gave her the three-laminated sheets that hang on the sawhorse sign ...intending to show her the story about Christin Gilbert who died on January 13th this year, due to complications of her abortion. After talking to her for a long time, the couple went into Tiller's and got an information pack. However, immediately after getting the information pack they walked back out to the gate and continued talking with Monica and Therese. While they were talking, Keith from Operation Rescue West showed up and talked to the gentleman. Choices Medical Clinic was closed, so they could not send them there, however, Monica and Therese encouraged them to come back to Choices tomorrow. *(They let them keep the laminated sheets.)* Keith confirmed that in his conversation with the gentleman that they were not going to go through with an abortion.



Friday, November 4, 2005:

CONFIRMED SAVE: An Hispanic family from Garden City, KS including two parents (?) an obviously pregnant teen-age daughter, and a young child, came in to Tiller's parking lot to drop-off the teen-ager for what would have been a late-term scheduled abortion. However, on their way in, Donna was able to talk to them and to give them literature in both English and Spanish. *(It was fortunate that Donna had the Spanish Literature with her.)* To Donna's surprise the mother did not stay in with the teen-ager, but rather came outside to wait with the others in the car in the parking lot. While waiting for the daughter to have the abortion, the apparent father of the girl read the literature that Donna had given them. About 15 minutes after they had gone in, they appeared at the gate again in their car, outbound from Tiller's parking lot. The man who was driving told Donna that they had changed their mind about having an abortion and that they were going back to Garden City. The pregnant girl was in the back seat, and Donna could see that she had not had an abortion. *(Furthermore, she had not been in long enough to have even an*

early term abortion.) Donna offered a hand-made baby-blanket as a gift for the baby, and they accepted it.

Monday, November 7, 2005:

CONFIRMED SAVE: A middle-aged Black lady in a black SUV, KS tags, county unknown, was turning around in Choices parking lot, having apparently missed Tiller's driveway. She stopped on Choices driveway to talk with Donna. She told Donna that she was looking for Tiller's. Donna tried to talk her out of going into Tiller's and gave her literature, which she seemed interested in reading. However the lady then revealed that she was only going in, to be with her daughter, who was already inside Tillers! About 20 minutes later, just after noon, a young black lady in a separate vehicle came out of Tillers, followed immediately by the Black lady above whom Donna had spoken to. Both vehicles stopped and the young lady told Derek, who had replaced Donna on-site, that she had changed her mind, and that she was not going to have the abortion.
